The Good Humanitarian Donorship (GHD) initiative facilitates collective advancement of GHD principles and good practices. The key objectives of the GHD group are: promote understanding and implementation of GHD principles and good practices, provide an informal forum for open and frank exchange of donor views and experience on GHD implementation, pursue joint activities and peer learning, facilitate dialogue with key partners on issues relevant to the GHD agenda and the effective functioning of the humanitarian system.

Main themes for 2012 – 2013:

- 1. Consultancy led analysis on how to bring the GHD agenda forward in the coming years.**
- 2. Linking Relief, Rehabilitation and Development (LRRD).**
- 3. Review of GHD indicators (continuation of work).**

As several of the work-streams included in this plan are building on processes and outcomes from previous work-plans and as it is likely that many ongoing activities will continue beyond 2012/13, this is considered an agreed rolling work-plan which will act as a framework for the coming year.
